Membership Qualifications And Dues Formulation

Regular Member Definition:

Any firm, partnership or corporation headquartered in North America that manufactures bitumen-based shingles, built-up roofing materials, modified bitumen roofing systems, or allied products, is eligible for Regular Membership in the Association upon terms to be fixed by the Board of Directors.

Dues Formulation (Regular Membership Only):

The regular member dues will be determined on a formula based on a three-year average of Member Company reported roofing sales:

Associate Member Definition:

Any firm, partnership or corporation who, in the judgment of a majority of the Board of Directors, supports the purposes and activities of the Association and is engaged in supplying major components, equipment or services for the manufacture or installation of bitumen-based shingles, built-up roofing materials, modified bitumen materials, may be admitted to Associate Membership in the Association. Associate members shall have the rights, privileges and obligations of membership except the right to vote.

Ten Million to Fifteen Million in Sales in the Asphalt Roofing Industry:	\$8,398
Over Fifteen Million in Sales in the Asphalt Roofing Industry:	\$13,115
