



ARMA Survey Participation Giveaway Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility: The ARMA Survey Participation Giveaway (Giveaway) is open to all roofing contractors who attended the International Roofing Expo (IRE) in New Orleans, Louisiana and who respond online to the ARMA QARC Awards Program Survey (Survey). Entrants are subject to all applicable federal, state and local laws and regulations. Void where prohibited by law. No more than one entry per eligible roofing contractor business entity.

In the event of a dispute, all entries will be deemed to have been submitted by the owner of the email account from which they were sent. For these purposes, an email account holder shall mean the natural person assigned to such email account by the Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with such email account. Survey responses become the property of Sponsor.

Sponsor assumes no responsibility for computer system, hardware, software or program malfunctions or other errors, failures, delayed computer transactions or network connections that are human or technical in nature, or for damaged, lost, late, illegible or misdirected entries; technical, hardware, software, electronic or telephone failures of any kind; lost or unavailable network connections; fraudulent, incomplete, garbled or delayed computer transmissions; or by any technical or human error that may occur in the processing of submissions that may limit, delay or prevent an entrant’s ability to participate in the Giveaway.
