



## ARMA's Excellence in Asphalt Roofing Awards Program

### Awards Submission Rules

1. By submitting a project and associated photographs, details, and materials (herein called *Materials*) for consideration in the Excellence in Asphalt Roofing Awards Program (herein called *Excellence Awards*), you and/or your firm (herein collectively called *You* or *Yours*) are representing that *You* have read and agree to these Awards Submission Rules.
2. You will retain ownership of the copyright to the *Materials*, but by submission, *You* hereby grant the Asphalt Roofing Manufacturers Association (herein called *ARMA* or *Sponsor*) a royalty-free, nonexclusive, worldwide, irrevocable, perpetual license for unlimited use of the *Materials* without further participation, review or permission by *You* and without payment of compensation to *You*. The sole consideration for the rights granted to *Sponsor* is *Your* entry into the *EXCELLENCE AWARDS* Program for consideration of an award.
3. This license includes, but is not limited to, the nonexclusive right to make the *Materials* available to third parties for:
  - distribution in connection with *Sponsor's* press releases;
  - publication or use in relation to the *EXCELLENCE AWARDS* Program or other *Sponsor* materials, activities, projects, or uses including brochures, bylined articles, website, videos, and other collateral.
4. By submitting *Materials* for consideration in the *EXCELLENCE AWARDS* Program, *You* warrant and represent that:
  - Either (i) that *You* are the owner of the *Materials*, that *You* alone own the copyright, that no other party has any right, title, claim or interest in the *Materials*, or (ii) that *You* have received permission in writing from the owner of the *Materials* to grant to *Sponsor* the rights granted herein;
  - *You* have obtained any necessary third-party releases and permissions for *Sponsors'* use of the *Materials*, including without limitation releases and permissions from the owner(s) of the building(s) appearing in the *Materials*;
  - that the *Materials* are *Your* own original work, or, if not, that you have received permission in writing from the creator(s) of the *Material* to enter the *Materials* in the *EXCELLENCE AWARDS* Program;
  - that the *Materials* are an authentic and accurate depiction of the subject matter presented and that the information contained on *Your* submission form is complete, truthful and accurate;
  - the *Materials* do not violate the rights of others, including, but not limited to, the privacy, copyright, or other intellectual property or other rights of any third party.
5. If your project and *Materials* are chosen for an award, or publication on or in *Sponsor's* websites, publications, or press releases, *You* may be asked to submit, and *You* hereby agree to execute and submit, a personal release or location release.
6. All entries and *Materials* will become the physical property of *Sponsor* and none will be returned.
7. *Sponsor* is under no obligation whatsoever to use, post, or distribute any or all submitted *Materials*.
8. *Sponsor* retains the following rights without limitation:
  - to disqualify any project and/or *Materials*;
  - to remove or delete any project and/or *Materials*;
  - to rename any project to better suit the judging process.
9. *Sponsor* reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the *EXCELLENCE AWARDS* Program.



10. All decisions made by *Sponsor* are final.

11. Indemnification. *You* agree to defend, indemnify and hold *Sponsor* harmless from and against any and all liabilities, causes of action, claims, demands, suits, judgments, losses, damages, costs, and expenses of any kind and nature, including legal expenses, imposed on, incurred by or asserted against *Sponsor*, its agents, employees, officers, directors, members, successors or assigns, in any way relating to or arising out of the *Materials* or *Sponsor's* permitted use of the *Materials*.

12. Applicable Law. The *EXCELLENCE AWARDS* Program and *Your* and *Sponsor's* obligations in connection with the Program shall be construed in accordance with and governed by the law of the District of Columbia, the jurisdiction of incorporation of ARMA, and the location of its principal office.

13. This *EXCELLENCE AWARDS* Program is void where prohibited by law.
